#### Secretary's Report Tommie Cochran

Mary Walton, President, called the meeting to order at 1:15 p.m. after lunch was served.

The Secretary's report from the previous meeting, read by Tommie Cochran, was approved by the group.

The Treasurer's report, read by Wanda Wells, showed a balance of \$1,827.18. It was approved by the group.

#### OLD BUSINESS

Calendar Project:

The Calendar project was discussed. It was decided that there had been enough response to go ahead with the project.

It was mentioned by several present that the register was not being signed by many of those attending the reunion. Various suggestions were made including assigning a floater to assist in registration.

#### NEW BUSINESS

A Memorial quilt for the 1990 Reunion was discussed for Williams auctioning. Pat agreed to check On the feasibility of this idea, and report at the next meeting.

There was a lengthy discussion on what would constitute quorum, and how many members of the association must be present before there can be a valid transaction of business conducted. A motion was made that before a business meeting can be held that there must be minimum of ten members present, and there must be a vote by the majority of ten before there can be a valid transaction of business conducted. This is to be added to the By Laws. The motion Was seconded and approved by the group.

A discussion resulted in the information from Lloyd Wells, Parliamentarian, that a special meeting can be called by the President or, in her absence, the Vice President, but only the business for which the meeting was called can be discussed.

A motion was made that the cooperation address be changed to Wanda Wells, Treasure, so payments can be made timely. After discussion, it was approved by the group.

Announcements were made, of correspondences received, by the president.

Pat Williams agreed to secure a place for our next regular meeting on April 21, 1990.




