At our fall 2006 reunion, family members traveled from all parts of the country and had a wonderful time. Approximately 250 to 300 members attended. A Wells Family Reunion 1915 photo in the Paintsville Herald had a count of over 800 people in attendance. We can not imagine trying to feed and provide lodging for all those people. We did not find an article that told what went on at the reunion but it must have been a great time. The picture was displayed at this past reunion. In the Boons Camp, KY newspaper, there was an article that said quite a crowd from there attended the Wells Family Reunion at Daniels Creek on the Nov. 13, 1915. The Paintsville Herald article appears below.

WELLS FAMILY REUNION.

"The local descendants of Richard Wells are making extensive preparation for a re-union of all the descendants of this pioneer settler of Johnson County, Kentucky. They have arranged for an old fashioned barbecue, to be held on the 13th of November, 1915, on Daniels Creek, at the grave of their ancestor, over which the United States Government has recently erected a monument with an inscription thereon showing Richard Wells to have been an Orderly Sergeant in the Virginia Corps of the Revolutionary Army. All the descendants of this pioneer are cordially invited to attend. A complete program is being arranged by Dr. John P. Wells and J. K. Wells of this place.

The Richard Wells mentioned in the above paragraph, lived with his father and seven uncles on Chestnut Street, Philadelphia, Pennsylvania, until the year 1773, when one of his uncles, George Wells, who was a practicing physician, took him to Virginia, where they lived for several years. During their residence in Virginia, Richard joined the Virginia army and fought for two turns in the Revolutionary war. Afterwards George and Richard went to Augusta, Georgia, where George practiced his profession and became wealthy. Richard, partaking of the nomadic temperament of his family, wandered back to Virginia and there married Susan Hutchison.

While in Virginia, Richard learned that Dr. George Wells had been killed in a duel, which he fought with General Abram Jackson and had left considerable property to Richard. However, when Richard went to Augusta to claim his inheritance, he found that a Mr. Jones, brother to Mrs. George Wells, had qualified as Administrator of the estate and had possession of same. In some manner the Jones decoyed Richard, who was then an old man to a deserted portion of the city and threatened to take his life if he again attempted to do anything about the property.

He then left Augusta, returned to Virginia and soon afterwards journeyed to the Big Sandy River, where he had many times visited while engaged in scouting expeditions against the Indians. Two of his sons stopped on the Kanawha River in what is now West Virginia and made their homes there. The Family of Wells pitched their tents on Daniels Creek, a tributary of John's creek, and soon hewed substantial homes from the surrounding forests. Here they lived, blazing trails, patenting and clearing lands, hunting and fishing until the year 1838, at which time Richard died and the family scattered in many different directions. The family of Richard Wells residing in this section at the time of his death consisted of the following children; George, Moses, William, John, Peter, Andrew, Betsy Hillman, Agnes Auxier, Rose Spears, Polly Butcher and Mrs. Bid Webb. The descendants of these, now living, number approximately eight hundred and quite a large per cent of these have advised that they will be present at the re-union."

Arrangements have been made to convey all those who attend from Auxier, the nearest railroad station and those coming from a distance are requested to come the evening before as arrangements have been made for accommodations at Auxier over night. One ox, six sheep, hams, chicken, eggs and all the eats have been secured. Speeches and family history will be related, relatives will get acquainted and a general good time is assured the relatives of the prominent family." Paintsville, Kentucky.

County mourns passing of Eugene 'Skeeze' Ward. Saltwell, In his book "The Greatest Generation" published a few years ago, retired NBC news anchor Tom Brokaw highlights the lives of men born and raised during the Great Depression who went on to fight on the battlefields of Europe and the South Pacific in World War II. Many of them left family farms where they helped their mothers and fathers, or other vocations, to enter military service. It was a sacrifice. These men and women helped transform our nation from its bleakest economic period to the standard of living enjoyed by their children and grandchildren today. Martin County lost a very worthy representative of this generation on Saturday with the passing Eugene R. "Skeeze" Ward, 89, at Kings Daughters Medical Center in Ashland. A World War II veteran, local businessman entrepreneur, civic leader and a member of Inez First Baptist Church and the Gideon's Association, Skeeze wore many hats and is regarded by many as a noted historian of the county. As a youngster, he attended

the old Himlerville School and he vividly recalled his memories there. He "packed groceries" from the old Himler Coal Company Store to the mansion on the hillside overlooking the town, recalling that it was "99 steps" from the bottom to the top. He was devoted member of the Martin county Kiwanis Club; club president Carol Sue Mills said only yesterday that Ward "will be sorely missed." "Our county lost one of its greatest citizens," Mills said. "He was so dedicated to the Kiwanis Club, his church and the community. His passing really hurts. A resident of Inez recalled running into Ward last week and Ward telling him that he wanted to get involved in a beautification project for the city. "That's the way Skeeze was," Mills said. "He was always looking at ways to serve the community." Earlier this year, a low-income senior citizens housing complex was named in his honor. A ceremony was held at the Roy F. Collier Community Center with a host of local business leaders and political figures in attendance. When an artist's rendition of what the facility would look like was unveiled, Ward commented to the audience that he wouldn't mind living in place like that "when I get old." After graduating high school (where he rode the old "Bobcat" from Tomahawk to Inez each day). Ward enlisted in Army Air Corp., where he served as a Tech Sergeant in intelligence during World War II. He was honored last year in a ceremony in Lexington along with other WWII survivors. After the war, he attended Pikeville College and taught school for two years. After working six years in civil service, he made his mark in the world in the automobile business. He became partners with Tom Williamson to form Williamson-Ward Chevrolet in Inez in 1954. He remained there until 1981 when his son, Dick, took over for the latter part of the business duration. He worked on helping build the new section of the Inez First Baptist Church, where he has served as a deacon since 1966. He belonged to the Gideon's Association since 1975 and is a charter member of the Highlands Gideon Camp. He was involved in the construction of the county's first physicians' building, serving as committee chairman. (Dr. Raymond Wells and Dr. Melissa Fletcher are currently practicing there.) He served on the Board of Directors of Family Bank in Inez for 20 years and served as member of the Big Sandy Area Development District for 20 years. He worked on getting the Rt. 645 bypass for Inez for approximately 8 or 10 years before completion, and was involved in projects which include channeling local creeks and starting the Martin County Water District. He was involved in getting the first modern

motel in Inez in a partnership with Tom Williamson. He and Williamson also had a sand plant on Rockcastle creek on old Rt. 3. He was instrumental in getting the road built on Saltwell. In addition, he has been very active with the Martin County Kiwanis Club, where he and his wife Gaynell, were Grand Marshal for the Kiwanis Harvest Festival Parade in 1999. He was a member of the Kiwanis Club's Board of Directors for 12 years and had perfect attendance for 10 years. Skeeze has also served on a number of state boards during the terms of Gov. Edward Breathitt and Gov. Julian Carroll. During Gov. Carroll's term he was appointed to the Judicial Nomination Committee for the 24th Judicial District in 1978, served as Council for Rural Development Commission in 1980. EUGENE R. "SKEEZE" WARD, 89, of Inez, KY., died 23 Dec. 2006 at Kings Daughter's Medical Center, Ashland, KY. He was born 7 Sept 1917 to the late Arthur Hansford & Melissa Jane Wells Ward. He is survived by his wife Gaynell Burke Ward; a son Richard E. "Dick" (Ina Mary Hinkle) Ward of Inez, grandchildren Lucinda Ward, Mary Jannetta (Mark) Muncy, and greatgrandchildren David Scott Muncy, Anna Catherine Muncy and Joshua Alexander Muncy, and sisters; Modell Sinning, of Cold Spring; Oretha Kinman, of Florence, KY and Eulah Villines of Dayton, OH. In addition to his parents, Ward is preceded in death by the following brothers and sisters; Olive ward Beach, Thelma Schwerman, Goldie Jump, Gailard Ward, Edward Ward, Carlie Ward and Clay Wells. His sister, Eulah, serves on the Wells Family Board. Eugene descends from Richard Wells through the William Green Wells line. Arrangements were under the direction of Richard-Callahan Funeral Home with the funeral at First Baptist Church. Paul Schmitt officiated. Burial was in the Cassady Cemetery on Coldwater, Martin County. The housing complex bearing the name "Skeeze Ward Manor" is scheduled to be completed by early spring.



PORTER ELEMENTARY FUTURE PROBLEM SOLVERS BECAME WORLD CHAMPIONS.


